# UNIT WELL #12

Drilled in 1957, Unit Well 12 has a pumping capacity of 2,270 gallons per minute. It operates yearround and delivers water to Madison's Near West neighborhoods including University Hill Farms, Sunset Village, Midvale Heights, Westmorland, Crawford-Marlborough-Nakoma, Orchard Ridge, Summit Woods, Meadowood, Allied Dunn's Marsh, Arbor Hills and Leopold. In 2023, Well 12 pumped 578 million gallons compared to its 5-year average of 566 million gallons annually.

Unless otherwise noted, data contained in this report, which is updated annually, are from 2023.

## Bacteria

In 2023, four quarterly samples were collected from Well 12 and tested for coliform bacteria, an indicator group of bacteria used to determine drinking water safety. Each sample was collected and tested before disinfection. None had coliform bacteria present. The Water Utility chlorinates drinking water to protect against bacteria and viruses that may be present in groundwater and to provide protection as water travels through water mains and premise plumbing.

## Hardness and Other Minerals

Like all groundwater, water from Unit Well 12 contains calcium and magnesium that contributes to its hardness (300 mg/L [ppm] or 18 grains per gallon). Other naturally occurring constituents that are present in water from Well 12 can be found in the <u>Inorganics Table</u>.

#### Iron, Lead, and Manganese

Water from Well 12 does not contain significant amounts of iron, lead or manganese.

#### Radionuclides

In 2020, water from Well 12 was tested for radium-226, radium-228, and other gross measures of radiation in water. Combined radium (226+228) measured 1.3 picocuries per liter (pCi/L) – well below the maximum contaminant level (MCL) of 5 pCi/L.

Naturally occurring, radioactive elements are found in rock, soil, water, and air. They derive from the creation of our planet and enter our bodies when we drink water, breathe air, and eat foods that contain them. Everyone is exposed to some level of radiation in everyday life. For example, uranium and thorium are found in rock and soil. In time, they decay to other elements including radium, which later decays to radon gas. Radon is the largest contributor to our daily exposure of radiation from the natural world. More information is available from the Agency for Toxic Substances and Disease Registry (<u>ATSDR</u>).

## Chromium

Low levels of naturally occurring chromium, including hexavalent chromium, have been found at Well 12. The level is well below the drinking water standard of 100  $\mu$ g/L for total chromium. More information can be found on the <u>chromium</u> page.

## Human-made Contaminants

Madison Water Utility annually tests all of its wells for human-made contaminants that may be present in groundwater. None of the volatile organic compounds (VOC) tested were detected at Well 12 in 2023.

The <u>Volatile Organic Compounds</u> table shows the list of substances that were tested, the results, and how the detected levels compare with the maximum contaminant levels (MCL) established by the EPA.

## Per- and Polyfluoroalkyl Substances (PFAS)

All Madison wells were tested for <u>PFAS</u> in 2023; none were detected at Well 12. In 2022, the Wisconsin Department of Natural Resources adopted drinking water standards for PFOA & PFOS set at 70 ppt. In April 2024, the US Environmental Protection Agency published final federal MCLs that were set at 4 ppt.
