## Hotels to Housing (H2H)

As of Dec 31st, 2022

234 total households enrolled currently

- 203 currently housed: 109 LSS, 53 The Salvation Army (TSA) & 41 EQUUS)
- 31 enrolled & searching for housing (24 singles & 7 families)
  - Majority of slots to be enrolled yet are for TSA families
- 259 Total housed to date
- 41 housed exits for various reasons (voucher, deceased, assisted living, etc.)
- 29 have been non-renewed/asked to leave (average of 11%):
   15 rehoused/to be housed, 12 have/need to leave/searching, & 2 exits

NOTE: Goal was for program to serve a total of 297 households. To date, H2H has served a total 329 households including 54 households enrolled (did not find housing) and exited due to various reasons. Placement into housing is an average of 78.6%.



## Dane CORE 2.0

 Since September 2021, Dane CORE 2.0 has distributed almost \$57 million in rental arrears, utilities, forward rent, and security deposits to 8,725 households in Dane County.

#### **Project Overview**

Oct. 14, 2022: The City of Madison is collaborating with Dane County to plan for and design a purpose-built shelter facility that will serve primarily men in our community who experience homelessness. The facility, to be built at 1902 Bartillon Drive, will be Madison's first purpose-built shelter. We are gathering feedback to ensure that it best meets the needs of those who will use it and the community more broadly. We know how important it is to engage folks with lived experience, service providers, and the neighborhood on shelter design and supportive service needs. The City will use this feedback to help inform decisions. In particular, this survey (closed Nov. 4, 2022) is designed to collect input from three specific groups:

- Persons who have experienced homelessness and who are currently using overnight shelter services, have
  used shelter services in the past, or have chosen not to use shelter services.
- Service providers and other community stakeholders who have, or do work with, unhoused populations and want to share their perspectives regarding the service needs they see in the community.
- · People who live, own, or operate businesses in or near the area where the shelter is planned to be built.

The survey was structured so that the questions it asks are different depending on which of the three groups you identify with. However, if you identify with more than one group (e.g. a service provider with lived experience) please consider taking the survey more than once so we can gather your feedback on all relevant questions.

This is a community effort, with the understanding that this shelter is not going to solve everything

#### Dane County Homeless Services Consortium 2023 Education and Advocacy Platform

The Homeless Services Consortium Education and Advocacy Committee proposes that the Homeless Services Consortium advocate for the following in 2023 to support those experiencing sheltered, unsheltered, and doubled-up homelessness, and self-paying in hotels:

- Increased number of units of affordable housing in Dane County, especially the number of units designated for individuals at or below 30% of area median income, as well as for policies that reduce barriers and increase access to affordable housing for those experiencing homelessness.
- 2. Increased funding for eviction prevention services in Dane County.
- Increased funding to expand and improve shelter services, including case management and housing navigation. Address gaps in shelter services including but not limited to shelter for families, couples without children and for parents under age 18.
- 4. Funding for homeless services agencies to **build capacity** within their organizations to enable them to innovate, expand, and improve efficacy.
- Reduced carceral responses to behaviors related to homelessness, mental health symptoms and/or substance use and increased funding for mental health and substance use treatment options that are accessible to individuals experiencing homelessness.
- Expanded partnerships with community businesses and institutions to increase and diversify funding for programs and services that will make homelessness brief, rare and non-recurring.

The Homeless Services Consortium Education and Advocacy Committee further proposes that the Homeless Services Consortium educate its members and the public on the following in 2023:

- 1. The Housing First model and its benefits to the entire community.
- 2. Effective strategies to prevent overdose and substance-use-related deaths.
- Decriminalization of homelessness.
  - Questions:
    - Would like to add the School Districts definition of homelessness the goal of this document was to provide a very board idea of what can be pursued not excluding specific types of homelessness.
    - electronic votes are a no go at this time due to the bylaws and concern that this is an open forum and electronic voting changes this
    - the reason for this documented platform was due to the limited capacity of E&A to have to go back and forth to the board and be impactful, this document if approved would allow E&A committee to be able to pursue these avenues without having to come back to the board for approval

- does E&A have specific plans to engage at this time no, are there specific priorities – E&A is still discussing opportunities, what is most important, where should the budget go to support, prioritization, E&A continue to keep their eyes and hears open for opportunity to positively impact our homeless community

## What are the Written Standards?

- > Department of Housing & Urban Development (HUD) Requirement
  - Continuum of Care (CoC)
  - Emergency Solutions Grant (ESG)
  - State EHH (Emergency Solutions Grant, Homeless Prevention Program, Housing Assistance Program)
- Guide operations that align with the HSC Community Plan to Prevent and End Homelessness and will:
  - Establish community-wide expectations on the operations of projects within the community;
  - > Ensure the system is transparent to users and operators
  - Establish a minimum set of standards and expectations in terms of the quality of expected projects

## Proposed Change to Coordinated Entry (CE) Section

- CE section of the <u>Written Standards</u> contains guidance about when to remove someone from the CE list
- P. 37, Section B, Paragraph 3, last sentence:
  - "Households that do not use emergency shelter or outreach services within the HSC for two years, will be removed from the priority list."
