NEW BUSINESS

- 2. Welcome to New Committee Members and Community Advisors
 - Newest member of the subcommittee, Angela Bozo was welcomed. An invitation has been
 extended to Aureliano Montes; he is unable to join at this point. The Community Advisors will
 be invited to our next meeting.
- 3. Discussion of Event Sponsors and Fundraising
 - Communication materials for Committee/Board/Advisors
 - A one-pager is designed; it will be sent to entire board not just this committee.
 Additionally it will be sent along with a welcome greeting from the committee chair to the Advisors. The goal is to get the document into the hands of potential sponsors.
